### POLICY CONDITIONS

Competition Glass welcomes your participation in our glass maintenance policy. This is not an insurance policy, but rather a service plan. Under the terms of this contract, you as the policy holder, agree to direct all glass claims exclusively to Competition Glass. All glass repairs to a home or business will be carried out during normal business hours. Emergency service is available at an additional charge to the policy holder. Competition Glass is conveniently located in Kelowna to ensure fast, efficient service. Coverage area is inclusive of Peachland to Lake Country. Any glass claims not serviced or authorized by Competition Glass will not be covered by this contract and will result in loss of coverage.

The policy holder named in this document will be entitled to replacement of exterior glass damage due to accidental breakage only. Competition Glass guarantees replacement of glass to exterior windows, doors, sidelites, sunrooms, dome/flat skylites, solariums and glass handrails. While patterned glass is covered under the terms of this contract, Competition Glass is not responsible for providing matching glass outside of the range of products normally carried as stock.

The following situations which might result in accidental breakage of glass are excluded from this contract and are not the responsibility of Competition Glass: breakage due to the home being transported and/or moved, damage due to faulty window frames, failed sealed units, faulty installation, fire, flood, earthquake, tornado, hurricane damages, sonic booms, acts of War, riots and all forms of unlawful assembly.

The following products will not be covered under the terms of this contract: leaded windows, grill frames, heat mirror, leaded or bevelled doors/sidelites, bent or convex windows, glass in greenhouses or detached buildings, glass in outdoor furniture and add-on or custom skylights to solariums or deck enclosures. Coverage is not provided for the replacement of lettering, burglar alarm systems or add-on window film. Damage to window frames and doors are also excluded from this contract. The Glass Maintenance Policy does not cover glass replacement for the policy holder's vehicle.

### CANCELLATION

Cancellation of this contract may be initiated by either party. If there is evidence of misuse of the contract by the policy holder named on this document, Competition Glass is required to provide the policy holder with 24 hour notice of cancellation.

All properties are subject to inspection before final contract approval. Claims made Within 30 days of activation of policy are subject to review.

If more than 2 claims are made during the annual policy period, Competition Glass reserves the right to inspect the contracted property and/or refuse renewal of this policy.
